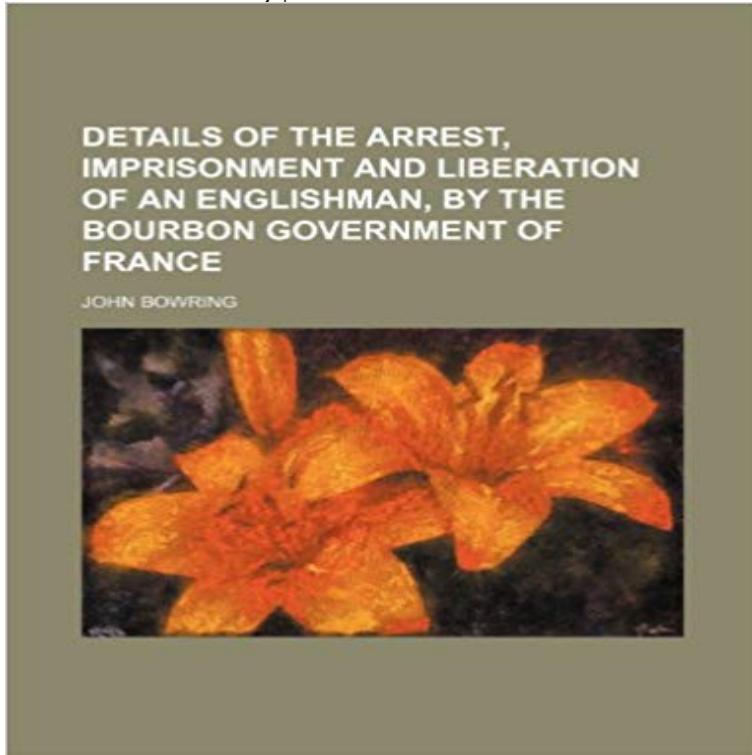

We, the Kings Advocate at the Tribunal of First Instance, sitting at Boulogne, in consequence of the Order issued the 14th of this month, by the Judge of Instruction of the Tribunal of First Instance of the Department of the Seine, for the removal of Bowring detained at Boulogne, and legally notified to him by an act of to-day; which the said Bowring refuses to obey, on the grounds stated in Article 100 of the Code of Criminal Instruction, Order the Jailer of the prison of the said Boulogne to receive and keep the said Bowring until further orders. Done at Boulogne, 16th October, 1822. John Bapt. L. Max. Caron De Fromontel. The rest announces the notification of the above. There is a strange anomaly between the documents G and H.
