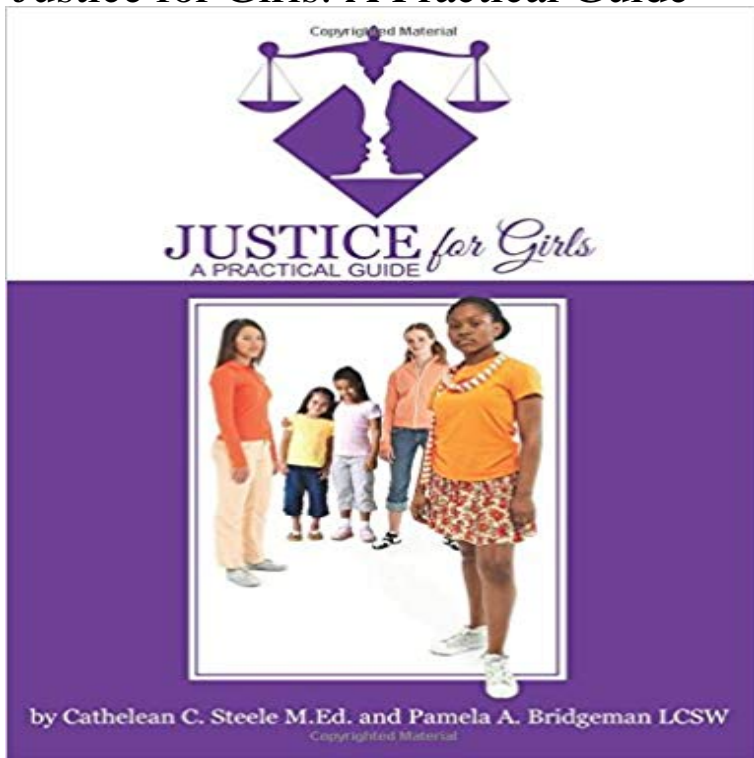


Justice for Girls: A Practical Guide
