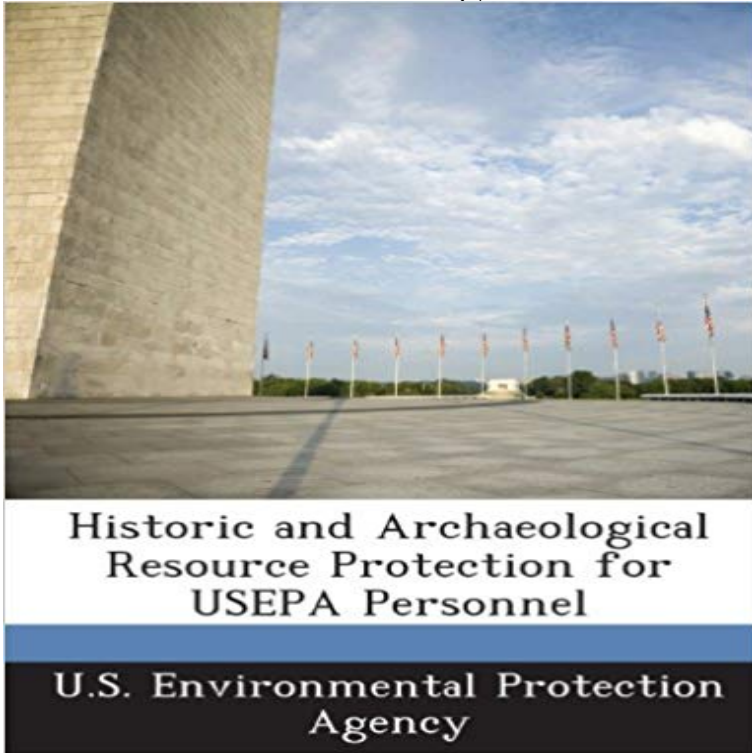


Historic and Archaeological Resource Protection for USEPA Personnel
