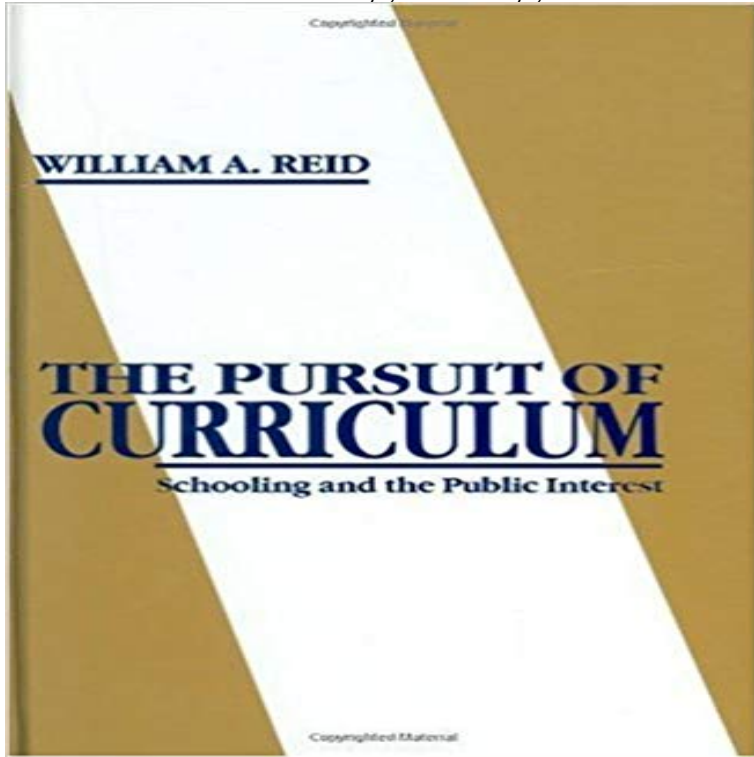


The Pursuit of Curriculum: Schooling and the Public Interest (Issues in Curriculum Theory, Policy, and Research)
